SOUTHGATE TOWN HALL STAFF WAR MEMORIALS

Unveiled in their new home



The Southgate Town Hall Staff War Memorials, originally situated in the main entrance to Southgate Town Hall, commemorate employees of Southgate Council who died in action in the two World Wars. They now have a new home in Palmers Green Library, Broomfield Lane, Palmers Green N13 4EY.

The memorials were formally unveiled by The Mayor of Enfield, Cllr Saray Karakus, as part of a moving ceremony in the Palmers Green library at 11am on 30th January 2019, in the presence of relatives of some of the fallen. The names of all the men commemorated were read to the assembled gathering, as well as readings from 'For the Fallen' and the 'Kohima epitaph'. The bugler sounded 'The Last Post'.

We were pleased to be joined at this ceremony by members of Southgate District Civic Trust, staff from Enfield Library and Enfield Museum, local community groups, as well as Civic Voice. Joanne McCartney our Assembly Member and a number of Councillors representing wards that formed part of the old Southgate Municipal Borough were also present.

The military were represented by members of the 4th Battalion, Princess of Wales's Royal Regiment and a bugler from The Welsh Guards.

The War memorials were removed from Southgate Town Hall in 2012, by Museum of Enfield staff when the building was acquired for residential accommodation. They remained in storage until they were placed in the Palmers Green Library, next door to the old Town Hall on 9th November 2018.

We are delighted that through the work of Southgate District Civic Trust members, staff from The Museum of Enfield, Enfield Library and the Local Studies team these memorials have been restored and are back on display.

Southgate District Civic Trust have produced a booklet to mark the event, which includes details of all the fallen, with a brief biography of each person. This was presented to everyone who came to the ceremony. We will make further copies available at future meetings.







POSTSCRIPT

It was known that there would be relatives of three of the men on the memorials at the ceremony, but it came to light that, unknown even to herself until the event, someone present was connected to another of the men, whose name was Tom Barry. It was his nephew's wife, Cllr Dinah Barry, who was at the ceremony in her capacity as a Ward Councillor on Enfield Council.

When she saw the information about Tom Barry in the booklet about the men, Dinah spoke to Eileen Bostle, who had done the research for it, and said she thought Tom, who came originally from Bradford, might be related to her husband John, whose family background is in the same city. This seemed fairly unlikely given that Barry is quite a common surname in Bradford, but discussion by email involving Dinah, her husband's sister Diana Kent, and Eileen, soon established that Dinah was right and that John is Tom's nephew.

Amazingly, Tom and John Barry came to Southgate for completely different reasons and at totally different times. Tom was appointed by Southgate Borough Council to the post of Superintendent at Barrowell Green Swimming Pool in 1940, and lived in the adjacent Bath Cottage with his wife and daughter. He was called up into the Navy the following year, and died when his ship was bombed during the Dieppe Raid in 1942. His body was brought back to Southgate, and he is buried in the Commonwealth War Graves Commission section of the cemetery in Waterfall Road. His nephew John grew up in Maidstone and attended London University, where he met Dinah. They lived in various places in North London before coming to Enfield in 1980, knowing nothing about Tom's connection with the area.



The final coincidence is that the north side of Barrowell Green, where the swimming pool and Bath Cottage were, is in Winchmore Hill ward which Dinah represents.

Thanks to Diana Kent we now have a photograph of Tom Barry, with his wife Elsie and daughter Sheila.

WILLIAM MORRIS (AND A FEW FRIENDS) IN SOUTHGATE

Spring Open Meeting Saturday 23rd March 2019

At this Open Meeting we were based in Christ Church Southgate, for a whole afternoon devoted to **William Morris**, the English Arts and Crafts designer and early socialist.

The afternoon started with a tour of Grade II* listed Christ Church by Fr Chrichton Limbert. As there were considerably more people than we had expected, it was a bit of a challenge to lead so many people round the church, but as Chrichton was such a great speaker, we all managed to see the wonderful artworks and building. He gave us a real insight into the history of the church, it's context socially, as well as showing us works by William Morris, Burne Jones, Ford Maddox Brown and Rossetti, including the Morris self-portrait. It was fascinating to understand how they came to be in the church and the pioneering processes used to create them, even if in one case it cost the church an extra 10 shillings!







After the tour, we all took our seats in the pews to hear **Ainsley Vinall**, Assistant Curator at the William Morris Gallery talking

about William Morris himself. He started by outlining Morris' early life as he had originally been training for the church. While at Oxford, Morris mixed with poets and artists, so decided on a change of direction, not exactly welcomed by his mother. It was during this time he met many of the artists he would work with closely in the future. We were given a fascinating description of his life, family, art and politics. However in the end what made him stand out and be so successful was his business acumen.



Ainsley then talked about the award winning William Morris Gallery in Walthamstow, opened in 1950 by the local MP, Prime Minister Clement Attlee. It is based in the Grade II* listed building that was the home of

the Morris family from 1848 to 1856. In 2012, after a major redevelopment the museum reopened to the public. Ainsley talked about their archive, the ethos behind the collections and some of the exhibitions arranged both at the gallery and abroad.

During the course of the afternoon we all gained a unique insight into these jewels of Southgate and the man behind them. It was a splendid afternoon – thank you to our speakers and everyone involved.







The William Morris Gallery is well worth a visit, so SDCT is arranging a curator tour for the afternoon of Saturday 11th May. The tour will be free, but





you must book. There are limited places available, but we may arrange two tours if enough people are interested.

ALL PARTY PARLIAMENTARY GROUP (APPG) FOR CIVIC SOCIETIES

These APPG meetings are organised by Civic Voice and chaired by Craig Mackinlay MP. As a member of Civic Voice, SDCT is able to attend these meetings in Parliament. It is a mark of the influence Civic Voice now has, that the speakers are MPs, Ministers and peers from across all parties.

25th February 2019: Putting communities at the heart of high streets

The meeting was quite brief, but packed with information from a knowledgeable group of speakers.

Jake Berry MP (Minister MHCLG for High Streets) discussed the Governments thinking on High Streets. The Portas report is about eight years old and since it was written much has changed on our high streets, particularly the impact of online shopping. The government has commissioned the Timpson report for a new strategy intended to rethink the High Street.

He asked what is our high street for? What will it look like in 5, 10, 15 or 20 years? Stating that it is key that local people and local groups are involved in any decisions and planning.



There were a number of questions raised from the floor, in particular about permitted development rights (PDR) converting offices into housing. Inevitably he stated this policy has created many new homes, but did not respond to the comment that PDR conversions are building the slums of the future. He seemed to dismiss the genuine concerns raised and implied that it was a London centric issue, not relevant elsewhere. However, an audience member, a RIBA architect, stated that PDR is removing sub standard offices, but raised concerns about the financial viability of conversion. An interesting view on this controversial policy.

The other speakers were: **Louise Brennan** (Historic England – Midlands) and **Emma Robinson** (Barnes Community Assn. & town centre manager). They both talked about the role heritage can play in the High Street as a 'pull' factor - breathing life back into our towns and cities. We were given lots of interesting and practical ideas based on their experiences working with the local community to regenerate high streets. It was very clear that it takes time and energy, but they had some useful ideas to make things happen.

27th March 2019: Public participation in the Planning System

There was standing room only at this meeting, with a group of speakers, who generated a meaningful debate with the audience.

Roberta Blackman-Woods MP (Shadow Minister for Planning) talked about the Labour Planning Commission (www.labourplanningcommission.co.uk).



This interesting new commission is consulting with all groups involved in planning, including community groups. Whilst recognising some recent Government ideas are good, they had a number of concerns. The commission's aim is to get back to basics and drive up standards to plan for the future. As she said, everyone understands the need for housing, but it must be of sufficient high quality.

The other speakers: Gavin Parker (Professor of Planning Studies, Reading University), Andrew Taylor (Director, Countryside Properties), David Knight (Director, DK-CM) and Nick Raynsford (President, Town & Country Planning Association) explained other aspects of the current planning system, which they compared to the system in other countries. Andrew Taylor gave a different perspective i.e. from the developer's viewpoint, a helpful insight.

The conclusions were that the Local Plan is important in reflecting what is key to a particular area, plus people need to believe their concerns are taken seriously and will not be ignored.



PROPOSED DEMOLITION OF A LOCAL LANDMARK

In 1859 the district of Colney Hatch was expanding. The main reasons for this were the opening of the huge Pauper Lunatic Asylum in 1851 and a new rail station being opened next to it. Gas was needed to supply the new houses being built in the area, so a gas works was built next to the railway, just south of the station, so that coal could be delivered by rail to the works.

It had the grand name of The Southgate and Colney Hatch GasLight and Coke Company, but was only a small operation at first, with just 65 consumers and 3 miles of mains. It produced about 1.5 million cubic feet of gas in its first year and had two small gas holders to store it.



In the 1870s the district had been renamed New Southgate and by the early 20th century the works had increased production to 105 million cubic feet a year and two new larger gas holders had been added. Then in 1912 the largest of the three holders was built. After another forty years production was over 1500 cubic feet a year, but in the 1960s, when natural gas was discovered in the North Sea, it was the beginning of the end for traditional coal gas and the works at New Southgate closed in 1972.

The site was demolished and a Homebase DIY store and car park was built over it. The only remaining link with the former gas works was its largest gas holder, overlooking the North Circular Road, which continued to be used for storage of natural gas until 2001. It was then decommissioned, but remained in a working condition, in case it was needed again.

At that time, it was intended to demolish it in the near future, so my Local History Society arranged with then owners Transco for a guided tour of the site before it disappeared. For whatever reason the demolition never happened. However, in the last few weeks it was announced by current owners National Grid that they now intend to demolish this iconic gas holder.

They are keen to give local groups an opportunity to remember the gas holder in some way. Some of the things that they have done on similar projects have included holding heritage events where local people have come along to talk about their memories of living near the gas holder and record them for posterity, saving parts of the gas holder for museums or local heritage groups and working with local schools to have tours of the site and create artwork of the structure.

Another tour has been arranged for a small group from the Local History Society and others who used to live near it. I expect this really will be the last time the site can be visited and with the Homebase store also closing earlier this year, that corner of New Southgate will soon look very different.

SOUTHGATE OFFICE VILLAGE, CHASE ROAD

The owners of the Southgate Office Village have for some time been exploring options to redevelop this site. Recently they held a public consultation to present their ideas to the community.

The plans include a mixed-use development with both offices and housing. Something that should be positive for our town centre. However, these plans have caused real concerns to all of us living in the area. They include three high-rise buildings, the largest of which is 18 storeys. The plans do not include any sustainable measures, such as solar power, green roofs or much in the way of open space. They also do not take into account the historic nature of the area, the conservation area and the iconic station.
