CORONAVIRUS SCAMS UPDATE

A recent message from Cllr Dinah Barry, sadly reminds us that there are people out there who are taking advantage of the situation. The advice from police: do not click on links or attachments in suspicious emails; never respond to unsolicited messages and calls that ask for personal or financial details.

Be extremely wary of anyone offering you a deal out of the blue. If an offer seems too good to be true, it probably is. Always question it.

THE POUND IN FOX LANE

The Pound in Fox Lane, at the junction with Bourne Hill and near the Woodman pub where its last Pinder, Henry Reed was landlord, is a reminder of the days when the district had a population of farm animals, horses and a miscellany of domestic species. If animals went astray and were successfully apprehended they would be kept at the pound awaiting their owner, to whom they were released for a fee.

Southgate Urban District Council took over the Pound in 1904, the last year it was in use and its successor Borough of Southgate commemorated its history on a small plaque placed to the north of the



enclosure. This bears the borough's coat of arms, one I missed in my survey of surviving examples in Newsletter 238 (October 2016).



There are detailed accounts of the pound in *The Story of Southgate* by Tom Mason (1948), Alan Dumayne's *Once Upon a Time in Palmers Green* (1988), Southgate District Civic Trust newsletters for April 1997 and April 2000 and in an article *Taking Care of the Pound* in *Oakleaves 3* (SDCT, 2004), which describes its restoration and improvements to the setting by Enfield Council. This was achieved with support from the Heritage Lottery Fund (£20,000), the Trust (£1,000) and Fox Lane and District Residents' Association. The Trust was consulted by the council about the plans for the restoration and material for the associated interpretation panel which had text provided by the Local History Unit.

A photograph in *Oakleaves 3* shows the then Mayor of Enfield, Yasemin Brett at the opening ceremony for the restored pound on 17 April 2002 in company with an 'impounded' Shetland pony and a goose from the Wildlife Rescue Animal Sanctuary at Trent Park (the goose being described as "belligerent" and "intent on escaping" in contemporary newsletter reports).

Repairs to the fence were carried out after a car went into the south side of the pound in January 2016, taking the interpretation panel with it. Enfield is currently a funding focus area for the National Lottery Heritage Fund and a project proposal for a



replacement has been put forward for consideration by them under the linked Call for Projects scheme which is being co-ordinated by the council's Heritage team.

MEMORIES OF BROOMFIELD PARK RUNNING TRACK

We received these memories of the running track from Peter Owen, a former Treasurer of Southgate District Civic Trust, following Richard Purver's article in the last edition:

As a six year old my family arrived to live in Ulleswater Road in 1948 when the firm, for whom my father worked, re-located to London from The Wirral. Ulleswater Road was very convenient for me spending time in Broomfield Park, even at the young age of six.

In that summer I spent some time sitting on the concrete seating (steps) overlooking the new running track. This was an official training track for the London 1948 Olympic Games. I was lucky enough to see a number of athletes training there in preparation for the London Olympics. The athlete I watched and noticed most of all was McDonald Bailey practising his start and speed from his sprint blocks *. This took place near where I was sitting. As you can imagine this was very exciting.

I was also very lucky as my mother took me to the 1948 London Olympic Games, at the White City, if I remember correctly. (I was also lucky enough to attend Super Saturday of the 2012 London Olympics). I did not see McDonald Bailey running, but I do have memories of a tall, fast Dutch lady running and winning the 100 metres (Fanny Blankers-Koen, I think her name was). She had very large baggy shorts. One of the fond memories of my first year (1948) in London.

When I was a few years older I played a small part in the "Three Elizabeths" pageant when I was still at Hazelwood Junior School. Many other Junior Schools took part in this pageant as well.

Later I got to run officially on the track when I was at Arnos Secondary School, as that was the only cinder track available that we were able to use in the early to mid 1950s in the area of Southgate B.C. (That was the venue for many years at school for our annual sports day before we had one built on the new playing field on the school site). We really appreciated the cinder track in those days so that we could break school records. We thought we were very good competing at what we thought were really fast times!!!! Well they were fast times then!!

When I left school I was lucky enough to enter cross country running competitions with Southgate Harriers (changing room for local events was a small hut near Hilly Fields – long gone now!) Lots of interesting memories – now many years distant.

* (Editor - McDonald Bailey was born in Trinidad, but competed for Great Britain. In the 1948 London Olympics he reached the final of the 100m, but finished sixth and last. However, he later went on to jointly hold the world record for 100m in the early 1950s at 10.2 secs).


