CIVIC VOICE UPDATE

Civic Voice response to Covid-19

Throughout lockdown and the Covid-19 crisis Civic Voice have been working hard, but with a different focus.

The team have been working to understand the effects of the crisis on civic societies. The civic sector is highly diverse, comprised of groups of vastly different sizes, operating under different models, with varying levels of activity, so the impact has varied. In order to understand the support groups like us need, they conducted a survey in April and May. The results of this make it clear that civic societies are in clear agreement as to which themes and issues they want the civic movement to be campaigning on after the crisis:



Bringing new life to town and city centres Giving local communities more influence in planning and place making decisions Protecting and enhancing Conservation Areas.

Local consultation, engagement and participation have a vital role in creating high-quality developments, but this depends on councils having well-resourced planning and conservation departments. Societies worry that these areas will reduce in priority for councils because local councils are now going to experience severe economic times.

Of course, the differences of civic societies means that a one-size-fits-all approach to supporting the sector is unlikely to work, but as part of their response and support to their members Civic Voice organised a set of webinars including the 'In Conversation' series.

'In Conversation'

These are a series where Civic Voice has a conversation with someone of interest to the civic movement, because they have a background or interest in planning, design, architecture, heritage and so on. They have been conducted via Zoom video conferencing, lasting around 30 minutes or so.

I have watched quite a few and they have been fascinating. I have not always agreed with the speaker, but why should I? However, I always come away with something to think about. Or even sending off for a book in the case of Bob Colenutt where he discussed his new book, 'The Property Lobby'. It actually makes very topical reading, since as I write Robert Jenrick continues to hit the front pages.


The new woodland composed of mixed native species, will allow natural flood management, but will preserve the historic context of the area.

THE SOUTHGATE COAT OF ARMS IN OAKWOOD PARK

I have noticed another surviving example of the Borough of Southgate coat of arms to add to those in my survey in Newsletter 238 (October 2016) and the one at the Pound in Fox Lane in Newsletter 252 (April 2020), but this time with interesting differences.



The plaque affixed to the gable of the pavilion in Oakwood Park commemorates its opening in 1929 when the local authority was Southgate Urban District Council. Listed on the plaque accordingly are W H Pullinger, Chairman of the Council, John Joy, Chairman of the Parks Committee, A E Lauder, Clerk of the Council and Robert Phillips, Surveyor. However the plaque was actually put up by its successor body the Borough of Southgate which was formed in 1933 and it carries their coat of arms and not the emblem for Southgate UDC, which was the Minchenden Oak behind a low fence with a gate at its centre.

This is also the case with the two similarly-designed Borough of Southgate plaques at the Morton Crescent entrance to Arnos Park which post-date its opening by Southgate UDC in 1928. Of note as well is that while in both locations the Borough of Southgate coat of arms has the Minchenden Oak, helmet, gate and sun in place it is missing the usual supporting stags. They are present though on the two plaques at the entrance to the Minchenden Oak Garden in Southgate, one of which records the opening on 12 May 1934 by His Worship the Mayor Alderman J T Barber JP and the names of Alderman John Joy, Chairman, Parks Committee, A E Lauder, Town Clerk and R Phillips, Borough Surveyor.



Oakwood Park was visited by Prince George (after whom the Avenue running alongside the park is evidently named) as part of his tour when he came to inaugurate the Borough of Southgate on Charter Day, 30 September 1933, accompanied by the Charter Mayor, Councillor John Barber and the Charter Town Clerk, A E Lauder. A guard of honour was provided by local Boy Scouts and music by the Honourable Artillery Company; the Prince inspected the children's playground (which was equipped with swings, miniature roundabouts and see-saws) and he and the Charter Mayor both planted oak trees nearby, as featured in the *Palmers Green and Southgate Gazette* of 6 October 1933 and *Southgate Charter Film* on the London's Screen Archives website. Small plates were placed at the foot of the trees with the words "Prince George Oak. Planted by H.R.H. Prince George,



Saturday, September 30th, 1933" and "Charter Oak. Planted by the Charter Mayor (Councillor J. Thos. Barber, J.P.), September 30th, 1933". I have not been able to establish whether these trees are still there among the oaks around the site today.

The playground and the refreshment chalet (as the pavilion is referred to) are also seen in Edgar Chard's 1950 film Southgate – A Glimpse of the Past (available as a Southgate District Civic Trust DVD), in which Robert Phillips is mentioned as the Urban District Council surveyor and engineer responsible for the old world-style bridges over the Pymmes Brook in Arnos Park.



Other specially planted trees in Oakwood Park include the poplar avenue to the north, for the coronation of George VI, and the scarlet oak avenue to the south. The plaques giving the names of successive mayors of Southgate and Enfield who planted the latter from 1945 to the 1980s have suffered over the years, with some missing and others disappearing gradually under the roots as the trees have grown. Still in situ is the one beneath the tall and

spreading scarlet oak planted by Alderman Mrs Ruth Winston JP in her mayoral year, 1958-59. One of her actions as mayor was to initiate the day facility for older people in Palmers Green now known as the Ruth



Winston Centre, which was opened on 7 March 1961 by Prince George's daughter Princess Alexandra.

ARTICLE 4 DIRECTION FOR ENFIELD

As you may be aware, in recent years this Government has made a range of changes to planning legislation. This has included extending the range of permitted development rights (PDR), that allow development to be carried out without going through the normal planning system or paying any contribution to infrastructure improvements that are needed. SDCV has long advocated that these rights should be rolled back, and planning decisions returned to local authorites, allowing input and scrutiny by the local community.

One of the most controversial PDRs is the one that allows the change of use from office to residential. This has allowed much of the local office space to be removed with a consequential impact on the town centre economy. These new dwellings are not subject to the same standards as new build, so in many case are rapidly becoming the slums of the future. Examples of conversion in Southgate include Southpoint House and Hobart House, as well as the offices above Chase Side shops.

Many councils have brought in measures to control PDR and bring greater oversight into the process. So, SDCV has been in touch with Enfield Council to determine what action they have or will take.

The leader of Enfield Council, Nesil Caliskan, has told us that 'officers are actively working on a new Article 4 Direction to bring under planning control the change of use from office to residential use in certain parts of the borough.'

A working group of councilors has been established to support and inform the preparation of the directive. Membership of this group includes lead officers and Cllr Aksanoglu, Cllr Bond, Cllr Gunawardena and Cllr Savva.

In order for this directive to be applied, it needs to address a clearly identified need, with a strong justification. Without this the Secretary of State will intervene and remove the directive.

We welcome the work this task force is doing and look forward to hearing more news in the near future. In the meantime, officers will update the council's website as work progresses. https://new.enfield.gov.uk/services/planning/article-4-directions/

We will provide any updates as they are received.

HIGH STREET REGENERATION: ENFIELD COUNCIL AND CIVIC VOICE

A successful, vibrant high street acts as the focus of, not only local commerce, but also of the local community. They are one of the few places where people from all backgrounds can meet and engage with each other. Yet, we know from both news reports, and the evidence of our own eyes, that high streets are currently facing many challenges.

Civic societies and community groups have been champions of our town centres and high streets for many years. In the past, it has been so easy for people to say, 'it is the responsibility of the council to take action'. That attitude is no longer acceptable. If we want to see our high streets and town centres succeed, we need to get involved. Councils have a key 'enabler/facilitator' role, but we can achieve so much more, as has been brilliantly demonstrated by the work of the **Palmers Green Action Team**.

So what about other town centres, like Southgate? We were pleased to watch the recent town centre business briefing on Southgate, where the Leader of Enfield Council and members of the regeneration team explained the work they are doing to help our local businesses reopen. We were extremely encouraged by the support being given across Enfield at such a pivotal time.

In response to our question on involving the community, Cllr Nesil Caliskan said that whilst the planned 'road show' had been postponed, they would be creating more 'engagement sessions'. She did not explain what this means, but we very much hope it will include something along the lines of our SOV Community Workshop.

In the meantime, SDCV is looking at new projects, ideas and discussion that members can take forward. More to follow, but if you want to get involved please get in touch.

As part of the High Street theme, Civic Voice has put together a series of webinars to help civic societies play a greater role in their community. The webinars will respond to the issues identified in the civic movement Coronavirus survey (see Civic Voice Update).

The webinars are open to civic societies, local councils and all organisations involved with high streets and include free access to online training programmes, webinars, data and intelligence on topics including recovery planning and coordination, public space and place marketing.

When Southgate District Civic Voice changed its name, we realised we have to reflect this change everywhere. However, that turned into a slightly more drawn out job than we expected!




So, we are delighted to announce we have a new website.

SOUTHGATE OFFICE VILLAGE

SDCV had been campaigning on behalf of the Southgate community for over a year for a fair debate about the proposals to demolish the existing low rise offices on Chase Road and their replacement with a high rise residential development seventeen stories high.

This followed on from intensive design development discussions and a preplanning consultation between the site's owner and Enfield Council's Planning officers which resulted in a planning application being lodged in Spring 2019.

A limited public consultation had been arranged by the developer early in 2019 and SDCV were shocked at its ineffectiveness and were determined that the community of Southgate should be more widely consulted on the proposals which would have a significant effect on the streetscape.

In June 2019 with the help of Civic Voice, (a national charity acting for Civic Societies across England), SDCV arranged a public exhibition of the development proposals at St Andrews Church including an open forum to discuss the local communities views, concerns and wish list for the development.

The results of the consultation were analysed and reported back to attendees and the local planning department.

Over 1000 responses to the planning application were submitted to Enfield Planning Department pointing out the antisocial nature of the development proposals. In response to the overwhelming public response, Enfield Council arranged a Planning review and presentation to the public at Highlands School.

The developer refused to substantially reduce the height of their proposals in response to community requests and the planning department recommended the application for approval at their planning meeting held on 23rd June.

The planning committee members, comprising nine Councillors, saw reason and unanimously rejected the application, voting against their planning officers recommendations for approval.

The vote clearly unnerved the planning officers, who resisted questioning when repeatedly asked how the design had been altered to take account of comments raised by the local Southgate community, because no answer was given.

The reasons stated for refusal were:
Bulk, Massing and Height.
Damage to the setting of the listed station
Negative impact on streetscape
Visual Intrusion
Failure to minimum target of 40% affordable dwellings
Detrimental impact on neighbouring properties

Stage Two of the planning process will be referral of the application to the Mayor of London Sadiq Khan who may be inclined to overrule the planning committee's refusal. Be in no doubt that the applicant will be submitting a planning appeal to the Planning Inspectorate as they will be determined to recoup their costs, overturn the planning decision and bank their development profit.

This result clearly demonstrates that in this instance the views of the local community could be heard and that local councillors will vote with the people if common sense prevails. For the time being we should all be happy with the result, celebrate our achievement and then get ready for the next stage.

Many thanks are due to those who made submissions to Enfield Council to Ward Councillors and to Civic Voice, who assisted with the presentation of the Community Voice to Enfield Planning Department. It just shows that if the developers had listened to what we said at our Community Workshop last June, they might have created a better design that we could all have supported.

We also especially thank Civic Voice, who facilitated the Community Workshop that kick-started the campaign and who throughout have provided unbiased advice and support. Not to forget all the other civic societies across the country who listened and encouraged us. It just shows what we, as a community can achieve.

Ian Harvey; Civic Voice Executive Director said: "I tuned into the Planning Committee meeting, and the one defining moment for the meeting for me, was not the vote itself, but it was when Cllr Leaver repeatedly asked whether any changes had been made to the development as a result of community feedback. None of the responses were, in his opinion, satisfactory and he concluded that the developer had not responded to the community voice."

STOP PRESS: COUNCIL CHANGES

At the Annual Meeting of Enfield Council on 1st July, changes to the Committee Structure of Enfield Council were proposed and this included the creation of an Environment Forum. This new forum combines the functions of what were previously the Green Belt Forum, Conservation Advisory Group (CAG), and Public Transport Consultative Group.

We are dismayed by this change, as it will reduce the in depth discussions held by each of these groups. It is not clear how the new Environmental Forum will work, as it has been set up without consulting the many volunteers who have worked for years to improve Enfield for all its communities.
